PERMIT APPLICATIONS

In order to interrupt the flow of traffic (either pedestrian or vehicular), a request must be made to the road's owner. Written permission is generally given to applicants by way of a Road Occupancy Licence (ROL) or letter of authority. This license will set out any special conditions, as well as the times and dates that work may be carried out on the roadways. Often there is a fee and/or a bond required by the road's owner. Coast Traffic Solutions will make the applications on behalf of our clients to obtain the necessary permits and ensure your project operates in accordance with local authorities.
